H. Fontenot, once county agent, dies HADLEY ALADIN

FONTENOT

Hadley Aladin Fontenot, 90, died Monday, March 28, 2005, in Lake Charles.

He was born in Duralde, in 1914. He was married to Wardella Morgan of Lake Charles 65 years.

Mr. Fontenot attended Vincent Business School, SLI (ULL) and received his BS and MS from LSU. He served in the U.S. Merchant Marines.

He was an agriculture teacher at Ville Platte High School and served as an LSU Extension Service County Agent in Jeff Davis, Cameron and St. Mary Parishes.

During his lifetime, Mr. Fontenot was deeply involved in each community in which he lived. He founded the Louisiana Fur and Wildlife Festival of Cameron and was its first president.

He was instrumental in establishing the Cameron Volunteer Fire Department and the Cameron Water Works District. He was elected to serve on the Police Jury from Jennings and helped form a water district north of the town. In Sweetlake, he formed Hebert's Summer Camp Association, which succeeded in building a community wharf.

Mr. Fontenot participated numerous agricultural, professional and civic organizations and was a charter member of the Ville Platte Lions Club. He was voted Cameron Parish's first Citizen of the Year. He received many awards, honors and recognitions for his outstanding contributions to local and state societies. Yet it was the marshes, lakes and ponds of Southwest Louisiana that Mr. Fontenot knew best. He was a hunter, fisherman and gardener. God blessed him with the ability to reap the bounty of the earth and his greatest joy was sharing that bounty with friends and family. He was a good provider and his family will miss one of the world's best "Camp Cooks". Mr. Fontenot is survived by one son, Judge H. Ward Fontenot, and his wife, Martha; one daughter, Lurchel Wittler, and her husdaughter, band, Mike; six grandchildren; four great-grandsons and one great-granddaughter. Funeral services were held Wednesday, March 30, in Johnson Funeral Home Chapel with Rev. Michael McLaurin officiating. Burial was in Graceland Cemetery. Ground broken for Sabine Pass LNG Terminal at Johnson Bayou

Federal, state and local officials joined with officers of Cheniere Energy to break ground for the Sabine Pass LNG Terminal on March 23 in Johnson Bayou. When com-plete, the facility will be the largest LNG receiving termi-nal in the U.S., able to transfer 2.6 billion cubic feet per day (Bcf/d) of natural gas with on site storage capacity of 10.1 Bcf/d.

The Sabine Pass facility will be able to provide 3% of the nation's natural gas needs, according to Federal Energy Regulatory Commission member Suedeen Kelly, noting it is the member largest LNG ever permitted by FERC. It was also the fastest LNG approval for the agency, which she said was due to Cheniere's hard work on their proposal.

FERC Chairman Pat Wood, a native of Port Arthur and no stranger to SW Louisiana, said the new terminal was important for the nation and will help provide reliable and secure energy for the future. FERC estimates at least eight new LNG terminals are needed to supply the nation's natural gas needs in the next few decades. Wood noted that Cheniere expects to build four of them.

Cheniere LNG President Keith Meyer said "The state of Louisiana and the people of Cameron Parish have risen to answer the nation's call for increased natural gas supply. This theme was vigorously echoed by state Department Network Resources manent workers, from opera-tors, to maintenance, to tug boat operators. He said LNG increased natural gas supply." Secretary Scott Angelle who called it a "great day for Cameron Parish, Louisiana, and America." Angelle gave credit to the Cameron Parish Police Jury, saying if it had not been for their support "we would not be here and this facility would not be a reality." He also credited Cheniere with being "environmentally responsible and responsive to community concerns." Angelle delivered Gov. Kathleen Blanco's message that "Louisiana is open for business, but only high qual-ity companies need apply." He said the first new LNG terminal to be started in 25 years sends a call out to America to pay attention to the 18th state to enter the union. Department of Economic Development Secretary Michael Olivier agreed that the facility "will propel our state forward in the nation and the world."



US REP. CHARLES Boustany, who serves on the Transportation and Infrastructure Committee of the House of Representatives, said the Sabine Pass facility will provide much needed jobs for Louisiana as well as liquefied natural gas "critically important to Louisiana's economy and the nation."

Congressman Charles Boustany, new U.S. Representative from the 7th Congressional District, noted the facility will provide much needed jobs for Louisiana and Cameron Parish. The facility will employ 300-600 construction workers and 60-80 peris critically important to the

Cheniere Energy. "Less than two years ago I met with Albert (Crain) and we wrote a deal on the back of an envelope," he said. He expressed gratitude to the federal and state agencies involved , but "especially the people of Cameron Parish," for making the ground breaking possible so quickly. He said "We want to be your neighbors and citizens of Cameron Parish for a long time to come.'



entire Awakening, people of all ages will be encouraged to "wake up to the possibilities of a fuller life in Jesus Christ,' according to First Baptist







Cheniere has begun the permit process for another LNG terminal, this one on the Calcasieu River at Cameron, to be called the Creole Trail Terminal. It will be even larger than Sabine Pass, handling 3.3 Bcf/d with a storage capacity of 13.5 Bcf/d. Added to the capacity of Sempra's Cameron LNG facility at Hackberry, Cameron Parish will have a great impact on the nation's energy needs.

Social Security Q & A

Question:

I stopped work at the end of last year, when I was 52. I don't expect to work again, and will probably file for Social Security retirement benefits when I turn 62. Will I still get the same benefit amount that is shown on the Social Security Statement that I recently received? Answer:

Probably not. When Social Security calculated your 35 highest years of earnings to estimate your future benefits on your Statement, there was an assumption that you would continue to work until age 62, making the same earnings you made last year. If, instead, you have zero earnings each year over the next 10 years, your average earnings will probably be less and so will your benefit. You can use the Social Security benefit calculators at www.socialsecurity.gov to see how this will affect your monthly benefit amount. Question:

The Internal Revenue Service has sent me a letter saying money for overdue taxes may be taken from my Social Security payments. Does Social Security allow that? Answer: If you owe overdue taxes to the IRS, money can be taken from your Social Security payments, reducing your payments by as much as 15 percent a month. However, before this would happen, you would get a letter from Social Security explaining how and why your benefits are being reduced.

As I'm sure that you know, South Cameron Memorial Hospital has been soliciting swingbed family members to use an out of parish supplier for your loved one's prescriptions and over the counter medications. Some of you have informed me that you were told that it is a law that you have to use that supplier because of their capabilities to unit dose and to save you money.

I want you to know that I can also unit dose for your swingbed family member so that you can keep his/her pre-scriptions at the Script Shoppe if you so desire. I have already gotten the supplies to unit dose the meds.

Most of you have Medicaid or private insurance, so the cost will be the same no matter where you go. As for the private pay prescriptions, I will do my best to match their prices. If I cannnot do so, I do not blame you for going to the other supplier, but please give me the opportunity to compare my prices with the other supplier.

If you send me a list of their prices, I can do a comparison for you. As for the over the counter meds, I am also told that for \$1 per card, they will unit dose those medications. I am offering the same. Also, in Cameron Parish, no taxes are paid on prescription medication whereas in Calcasieu Parish, one pays taxes on prescription medications. I also want you to know that South Cameron Memorial Hospital did not offer me the option to unit dose the swingbed medications. In fact, they did not even tell me anything about the switch. I heard it from several concerned family members. I have been supplying the hospital, along with Cameron Drug Store when they were open, since 1996 when I bought the drug store from Mike. Before that, Mike and Cameron Drug Store did it for many years. Throughout those years, they and I, when I bought the drug store, have totally supported the hospital through all the problems that they have had. We have donated much time and supplies to South Cameron Memorial. I, and I'm sure that they, have taken major losses on prescriptions that the insurances or Medicaid rejected and did not pay us for. I did not bill the patients or the hospital for the prices of the prescriptions that were not paid. I saw it as another way to try and help. For quite a while, the hospital has slowly been taking everything away from Cameron Parish. They've taken away good people's jobs and replaced them with ones from out of parish. Do they spend their checks and pay taxes in Cameron Parish like the parish employees did? Good people have helped the hospital over the years and are forgotten now. Now they're trying to take away business of what seems like our family members. How are businesses in this parish supposed to survive if the parish does not support

Red Cross and fire chiefs discuss fire aid program

American Red Cross representatives met with Fire Chiefs from around the parish last Thursday to discuss a project to help victims of structure fires. Kisha Killmer, Developmental Director, and Kaffy Fontenot, **Emergency Services Director**, explained to the chiefs that the Red Cross offers assistance to victims of fire and other disasters in the five parish area. They have responded recently to fires in Cameron and Hackberry, but the travel time makes it hard to get to families in a timely manner.

The agency asked for help in locating volunteers who would be trained in responding to single family fires. Killmer said having volunteers in each community would provide faster aid and people would probably respond better in a crisis to someone from their own community, a neighbor.


The Red Cross will provide the 16 hours of training wherever is most convenient for the volunteers. Training would include CPR and First Aid certification. Fontenot said the agency provides services for single families' immediate emergency needs food, clothing and lodging. She said they wish they could provide more, but resources have to be spread over a five parish area. Another service provided by the Red Cross is emergency communication from family members to military personnel 24 hours a day. Disaster doesn't sleep," Fontenot said. Advocacy is another area where the agency can help, by calling insurance adjusters and others whose help is needed. "When the Red Cross calls, it lights a fire," she said. The group is hoping for 8-12 people who will volunteer to be trained. Anyone interested can contact their local Fire Chief or the Red Cross, at 478-5122. Killmer said, "We understand there are some old issues dating back to Hurricane Audrey, but the Red Cross is here today offering help. We want to be a part of the solution for Cameron Parish people." Other issues affecting all the districts were also discussed, including Homeland Security grants and the upcoming move of the 911

console due to court house plumbing repairs. Freddie Richard, Director of the Office of Emergency Preparedness asked for a wish list from each department, but cautioned about the continuing cost of new radios.

The Homeland Security grant pays \$3500 for each new radio, but it costs the department \$600 to program each one, \$100 for local channels, and \$204 each year to keep it programmed through the state. He said each department will be paying \$2000 a year in user fees when the new radios are distributed.

All the older radios are about to become obsolete, however, as the state goes to a new system, so new radios are necessary.

Emergency Emergency personnel, including 911 dispatchers, discussed the best way to utilize the new consoles being purchased with grant funds. The new, expanded system, along with the proper use of radio channels, will allow dispatchers to work with, for example, a fire in Johnson Bayou, another one in Grand Chenier, and a wreck in Cameron without confusing the various personnel on the scenes. The system will not be fully implemented until the plumbing is complete, but having the extra console will make the transition from the second to the third floor smoother.

Congressman Boustany meets with Cameron folks

First term congressman Charles Boustany is "tired of the fact that Louisiana comes out last in every way" in its treatment by Washington. Boustany, who represents the 7th Congressional District, held a town meeting in Cameron last week to explain what he plans to do about the situation. He is in a position to speak up in Louisiana's defense, having been appointed to three important committees in the Congress: Transportation and Infrastructure, Agriculture, and Education in the Workforce.

On the Transportation committee, Boustany has been named vice-chairman of the Water Resources and Environmental subcommittee and is also on the Coast Guard and Maritime subcommittee. He reported that he has already used that position to ask why the Corp of Engineers has not made the dredging of the Calcasieu Ship Channel a priority, since the 30% of the nation's supply of LNG currently goes through the Port of Lake Charles. He said it will take \$34 million to bring the channel back to specifications and \$15 million a year thereafter to maintain it.

the ecosystem and infrastructure to do so, that the state should get a higher percentage back. He said the new highway bill just passed will give back 92 cents on the dollar, but it's only a start.

On the subject of infrastructure, Police Jurors asked for Boustany's help with a bridge or tunnel crossing of the Calcasieu Ship Channel. He agreed that with LNG activity Cameron Parish is of national significance for energy and will need faster means of getting across when traffic picks up. He said there is no study as yet, and nothing can be done without one, but he is putting in a request for study funds.

Loretta Meaux, representing the commercial fishermen of Cameron Parish said the fishermen are not opposed to LNG or other industry, since it brings jobs and improves the economy, but asked that improvements not come at the cost of taking away fishermen's living. She said fisheries have "unimaginably declined" as a result of water control structures that were not maintained properly after they were built.. She cited a structure that should have remained open except for hurricanes, which had been closed since 1913. Boustany pledged to hold the Corps accountable for its actions.

In an effort to focus national attention to the problem, he has proposed a bipartisan "Lower Mississippi River Caucus" along with Rep. Russ Carnahan, a Democrat from Mississippi. Right now, he said, Louisiana gets back 89 cents on every dollar it sends to the government in severance taxes, while some states get as much as \$6 for every dollar thev produce. Boustany thinks since Louisiana provides so much energy to the rest of the country, and takes the brunt of the damage to

discussion focused on the Security Social issue. Boustany explained that the President's ideas are only suggestions at this point, and he, personally, is waiting for more details before deciding whether to support them. He does believe changes need to be made and is asking for ideas from the public.

Boustany is opposed to any increase in payroll taxes, any changes in benefits for current retirees and those close to retirement, and privatization. He said he hasn't taken a position on "personal accounts" because they have not been defined and won't take care of the long term solvency issues all by themselves.

Dinah Landry, Executive Director of Cameron Council on Aging, said that present senior citizens who worked to support others through Social Security are concerned about the number of people today who don't work and are not putting money into the fund to support them.

Boustany said this points out the truth in Federal Reserve Chairman Alan Greenspan's recent comment that "For the first time in American history we will have the workforce pitted against retirees." He said it will take a lot of work to solve the problem.

GOLD POND

A couple of weeks ago, I said that things were looking good for anglers fishing Lacassine Refuge's Impoundment. I even commended the way they handled the drought problem we had back in 1999 to 2001.

The pool closed for a couple of years, let the water levels come back up, letting us go fishing in the pool, catch and release, for a year, then last year fish and keep five bass

This year the pool reopened and followed state bass fishing laws, 10 bass, no size limits, even the no tournaments was gone for this year. I did not like all the big bass being caught and kept, but some anglers were sore because of no tournament fishing, but again I could live with that.

In this six year period starting back in 2002, state and federal people restocked more than 400,000 Florida bass fingerlings, along with other species of fish. Many anglers spent a lot of their time and money to also help restock the pool.

Bass anglers were really interested in taking care of this great bass pond, which was producing large bass before the drought and again this year during the opening of the pool. Just look at opening day with an 11 plus pounder caught, plus all the 5 to 11 pounders caught.

This past week, my good friend Harris O'Blanc of Hayes lost out to his 11.62 large bass he caught back before the drought. Jimmy Miller of Lowery caught a 27 inch bass weighing 11.875 pounds.

I received a phone call about the pool being drawn down, which I couldn't believe was nothing but rumors, but with listening to the situation from anglers and thinking I couldn't believe this was happening. This to me is not a "mother nature drought," this is a "man made drought."

It is said by officials of Lacassine Refuge that they needed to burn the pool because of it closing in and that water had to be removed to do so. They also said the refuge was designed back in the late 1930s to hold 4.5 to 7 feet of water, and that the impoundment was built to manage waterfowl, and that the burning should have been done at least 3 years ago. Why didn't they do this three years ago or when the drought was there? Why did they let all the stocking of Florida fingerlings take place, if they were only going to destroy them in the end? I just don't see how they will ever get the trust of local fishermen again. They also want to build another levee to split the pool into three ponds instead of two, which won't hurt, but to destroy all the fish on their own is a sin. Dropping the water 14 inches will surely make many trails impassable and ponds shallow, then anglers may as well hang it up. We'll see two great boat launches idle and look like a ghost town again. I think the timing of this man made drought is way wrong. This could have waited at least until the end of May, because there will be plenty of growth and hot weather that slows fishing in the pool. I think maybe P.E.T.A. should come along and show this thing. They are always



trying to stop the fishermen. I don't see any difference in killing fish, except we are anglers and do eat the fish, or give to our neighbor, to let them have fish to eat. Maybe calling our U.S. Representatives and U.S. Senators could put a stop to some of this thinking!

They got the "Gold Pond." Anglers will get the "shaft."

GIBBSTOWN DOGFIGHT

The Monday afternoon fishing dogfights will begin April 11, with blast off time at 5:30 p.m. and weigh in at "dark thirty." Launching will be at the Gibbstown Boat Launch on the north side of the Gibbstown Bridge. Three bass will be weighed in with a minimum length of 11 inches. Fish are to be weighed in alive and released. All dead fish weighed in will be penalized 0.20 pounds. Dead fish will be allowed at the discretion of tournament directors. No cloudy eyed fish will be weighed. Fish must be brought to the scales in a plastic bag with water.

Teams must register at the Gibbstown Boat launch and the entry fee is 30 for a one or two man team; \$10 per boat big bass pot, which is optional.

Boat members will be drawn for blast off order, but anyone who registers after 5:15 p.m. will blast off in order of registration. Only artificial baits may be used. The two highest placing teams that have not previously qualified, (each week), will qualify for the regional dogfight. Teams not present at the awards ceremony will lose the right to qualify for regional tournament that week.

A person may qualify with more than one person, and fish with one of those and the other angler can fish alone as a team--all protests must be made before money is paid out. Pay out is 1 per 7.5 boats and all fishing has to be done out of a boat.

All state and federal regulations will apply, and again: this is a catch and release tournament. All fishing will be in the Intracoastal Waterway, east of the Gibbstown Bridge to include the Bell City Ditch, Lake Misere and public marshes. Anglers cannot expect their boats to get to a fishing area.

There will be no fishing closer than 50 yards from an anchored boat, unless invited to do so. No one on the water or pre-fishing this area on Mondays. Random drawings will be held each week for a polygraph test. No consumption of alcohol or illegal drugs during tournament hours. There will also be a trash fish pot at \$2 per boat optional. Entry fee is by cash only, exact change and no checks please.





Town meeting is held for Johnson Bayou/Holly Beach

A respectable crowd of civic minded residents attended a Town Meeting for the Holly Beach - Johnson Bayou Community, held Tuesday, March 15 at the Johnson Bayou Community Center. Police Juror Sonny McGee organized the event to provide local residents with information on the activities of the many boards and agencies serving the area. Representatives of the Police Jury, Sheriff's Dept., District Attorney, School Board, Fire Dept., Port Commission, Ambulance Waterworks, Dist., Drainage Dist., Beach Sewerage Dist., Dist., Recreation Dist., and Library were on hand to answer questions from the public.

Ray Miller, representing the Holly Beach Sewerage District, reported that a long term lease is being negotiated with Anache on two acres of land to be used for the treatment plant and the board is determining the best locations for the grinder stations. He said he expects to hear within two months whether their Community Development Block Grant application has been approved. The sewerage system is to be built with a \$2,218,000 loan and two grants totaling \$2,679,000. The loan is to be repaid by user fees. Miller said the system will need to take in \$22,000 a month to meet expenses.

ferry landing, which was recently damaged by a barge, was brought up. Upon investigation, it was found that the landing is on private property, and in order to invest public funds for its repair, a lease is being prepared. The landing is on undivided property shared by many heirs, and all need to agree to the lease before work can be done. Parish Administrator Tina Horn said that \$189,000 in rural development funds have been dedicated to the repair.

Several residents expressed concerns about tourism issues ranging from littering to 4-wheelers. Real estate developer Barry Hunt said there are many 4-wheelers and "loud, fast bikes" riding on the sand dunes and grass lines "tearing up the only protection from tidal surge." Several people blamed Texas riders for most of the problem, noting that in Texas it is now illegal to ride on any beach. Sheriff Theos Duhon said he has 4-wheelers and that some deputies even use their own vehicles to patrol the beach when off duty. In the summer he hires extra help, but still cannot afford full time patrol of the beaches. Constable Tim Trahan is planning to take the necessary courses to write tickets on the beach, and intends to patrol for speeders as well and dune violators. Duhon also explained that citizens can help by reporting incidents, including littering. He said two witnesses making a statement and being

willing to appear in court would make a good case. District Attorney Cecil Sanner agreed, adding that a photograph of the offender, including the license plate if possible, would be a great help. Duhon also revealed that Chief Deputy Ron Johnson is looking into a Citizen On Patrol (COP) program. Under this program private citizens are trained to observe and report infractions. The are given a uniform, vehicle, and radio, but no weapon, and have no arrest power. No decision has been made as yet. He said an auxiliary officer program is not possible at this time due to insurance costs.

When asked whether the department has any four wheel drive vehicles able to go off road on the beach or elsewhere. Duhon replied that a 4WD vehicle is on his wish list, but not a top priority since he first needs to upgrade his 18 year old com-puter systems. He said "If I had another million dollars I could have another 10 officers and 4WD vehicles. but I don't. so we have to do the best we can.' Duhon also offered to help residents \mathbf{set} up Neighborhood Watch programs to keep an eye on each other's property and any suspicious activity. District Attorney Cecil Sanner reported that he has an office in Cameron and in Hackberry, and that Assistant DA Tom Barrett is located in Grand Lake and ADA Jennifer Jones is also avail-

Lafayette, La. (March is Women's History Month. The following column examines how the nation's Social Security program affects American women.)

March is Women's History month -- a time to focus not just on the past, but on the challenges women continue to face in the 21st century.

Social Security plays a vital role in the lives of women. With longer life expectancies than men, elderly women tend to live more years in retirement and have a greater chance of exhausting other sources of income. Today, women represent 58 percent of all Social

able in Cameron, so that people can easily meet with one of them when needed. He reported that since Jan. 1 there has been a rush of child molestation investigations. He said half of them have been juvenile on juvenile, and the other half have been parish residents. Sanner noted that the parish has about 90 DWI cases each year, which averages about one every four days. Since only 25% of DWI's are generally caught, the total number of drunk drivers on Cameron Parish roads is significant. He said the number of marijuana cases is usually small, and he compli-mented the Sheriff's Office on the increase in hard drug arrests for drugs such as cocaine and hydrocodone. He believes that even though some may experiment with drugs on weekends, "the vast majority are good kids and do not have a drug problem.' He said his students are "the best group of kids I've ever been associated with." 
