## Attorney General is visitor to School Board

Louisiana Attorney General Charles C. Foti was the special guest at Monday's meeting of the Cameron Parish School Board. A number of local dignitaries were on hand to greet the Attorney General and watch as he presented awards to seven local school children who participated in his American Spirit Poster Contest.

Foti noted that of the eight local winners whose entries were sent to Baton Rouge, three won state awards, and one was a grand prize winner.

The art program, which is an outgrowth of the one Foti started in Orleans Parish as Sheriff, is designed to rejuvenate patriotism in children and is tied in with the D-Day Museum.

Dina Mendez, from Cameron Elementary School was named the Louisiana Resource Center for Educators Grand Prize Winner, one of five overall awards. Her colorful poster depicting four children hanging an American flag on a tree has been reproduced on postcards to be sent to troops overseas.

Keylee Young, of Johnson Bayou School, placed third among second graders statewide, and Timothy Russell, of Grand Lake School, placed third among seventh graders statewide.

Other local winners honored were Kimberlyn and Blake Hebert, parish kindergarten and first grade winners, and Ian William Ray Griffith, parish third grade winner, from Johnson Bayou School; Samantha Little, parish fourth grade winner, from Hackberry School; and Gabe LaLande, parish eighth grade winner, from South Cameron High School.

Foti also announced a new program to begin in school soon called "Know the Law,"

in which attorneys will speak to students about rights and responsibilities of citizens.

### GRAND CHENIER SCHOOL ISSUE

School Board member Dot Theriot brought up the subject of the closed Grand Chenier Elementary School once again, but said she was "not prepared to ask for a vote at this time, "but wants to present more information at future meetings to "find ways to use the school or to give it back to the heirs."

Theriot presented a revised cost estimate for re-opening the school which she said was more accurate than the one presented last month. Her figures show the annual cost to operate the school would be \$618,844, or \$54,332 less than the previous estimate.

Theriot also provided a breakdown of the tax revenue received by the school board from each school district. She noted that under the 10.6 mill parish-wide school tax, Grand Chenier's annual total of \$318,000 is greater than Hackberry (\$170,978) and Grand Lake (\$145,432) combined (\$316,410).

She also noted that the southern part of the parish produces 79% of the total revenue, and in District 10 (which includes Cameron, Creole, and Grand Chenier) the Grand Chenier district provides over one-third of the revenue, yet the district does not have a school of its own.

Other school board members said they would reserve their comments for another meeting, in view of the large number of guests waiting to hear the Attorney General.

Grand Chenier resident Teddy Broussard, a frequent local speaker, gave a history of Grand Chenier's contribution to education and complained that "our students are

He invited all interested persons and businesses to participate in the Chamber by attending its monthly meeting held the second Wednesday of each month at 2:30 p.m.

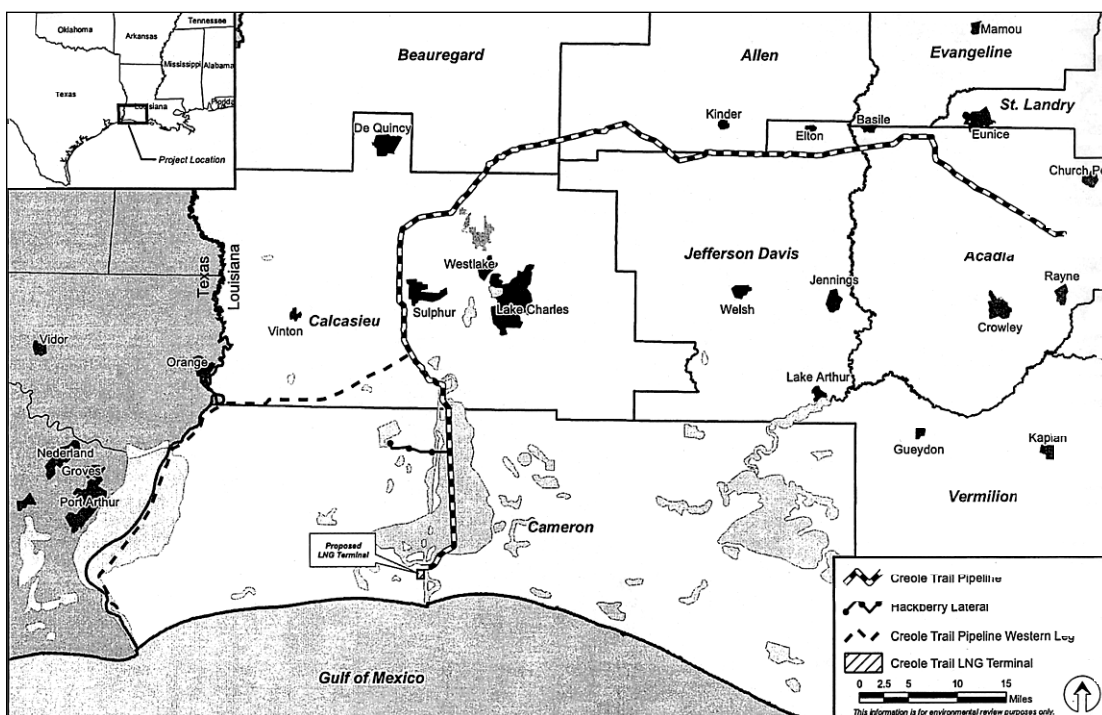

However, by any name, the ferry has only three more years to operate before it is shut down by the La. Dept. of Transportation. It is hoped by then a bridge will have been built connecting the island with the town of Cameron.

# Creole Trail LNG plans include terminal here

The Federal Energy Regulatory Commission is preparing an environmental impact statement on the environmental impacts of the Creole Trail LNG and Pipeline Project involving construction and operation of facilities by Creole Trail LNG L. P. and Cheniere Creole Trail Pipeline Company. The proposed facilities would consist of a liquefied natural gas (LNG) import terminal, an approximately 118-mile-long dual send-out pipeline with an approximately 47-mile-long single pipeline (Western Leg) and an approximately 6-mile-long single pipeline (Hackberry Lateral).

The LNG terminal would be located on approximately 773 acres of a 1,463-acre tract of land in Cameron Parish, approximately 3.03 miles inland of the Gulf of Mexico, west of the Calcasieu Ship Channel, and northwest of

Monkey Island.

The LNG terminal would include two marine berths to accommodate ships with up to 250,000 cubic-meter capacity, four 160,000 cubic-meter single containment LNG storage tanks, and three banks of seven submerged combustion vaporizers (which includes two spare submerged combustion vaporizers).

The terminal would provide 3.3 billion cubic feet per day of send-out capacity, approximately 400 ships per year are anticipated to call on the terminal.

The Creole Trail Project would include two parallel and adjacent 42-inch-diameter sendout pipelines that would originate at the LNG terminal site and extend approximately 118 miles in a north-northeasterly fashion to the vicinity of Columbia Gulf Transmission Company's Rayne Compressor Station

located in Acadia Parish. The pipelines would cross Cameron, Calcasieu, Beauregard, Allen, Jefferson Davis, and Acadia Parishes.

The proposed Creole Trail Project would also include the Creole Trail Pipeline Western Leg, an approximately 47-mile-long, 42-inch-diameter single pipeline originating from the proposed sendout pipeline south of Sulphur, and extending across Calcasieu and Cameron Parishes to the Sabine Pass LNG, L. P., Terminal facility, and the Hackberry Lateral, an approximately 6-mile-long, 36-inch-diameter single pipeline originating from the proposed sendout pipeline in Calcasieu Lake and extending westerly where it would terminate at the Dominion Hackberry salt cavern storage facility in Cameron Parish.

now sent to dog houses, t-buildings out in the pasture, with no water and restrooms 200 to 500 feet away." He said "people are tired of paying taxes with nothing coming back."

## BIDS AWARDED

South Cameron Elementary School will get a new playground pavilion, South Cameron High School will have its track rebuilt, and Hackberry High School will get a new running track with field events venue with the awarding of a combined bid package.

Asphalt Associates submitted the low bid of \$575,258 for all three projects. The bid award included an alternate item to seal South Cameron High's new rubberized track for longer life.

Supt. Doug Chance said the bids were higher than estimated a year ago due to two factors. Through discussions with the architect, some alterations were made to the plan, including adding a north enclosure and 4 ft. drop sides to the pavilion with a canopy to connect it to the school for protection from the weather, and adding a layer of crushed rock to each track for greater stability and longer life.

Also, the price of steel, cement, and petroleum based products such as rubber and asphalt have been rising quickly due to great demand from China.

Chance recommended building now instead of delaying while the prices continue to rise.

Board President Loston McEvers said it will be cheaper to do all three projects under one bid and all three projects are needed. Board member Rachel Abadie said the pavilion is greatly needed, and noted that Grand Chenier children who attend South Cameron Elementary School and South Cameron High School will benefit from these projects. She hopes that future savings on repairs to the South Cameron High School track will allow more dollars to go into the classrooms.

Board member Marvin Trahan was the sole opponent to the bids package, saying he was in favor of the pavilion, but opposed to spending any large sums of money on tracks at Hackberry and South Cameron when Grand Lake's track situation is even worse.

Grand Lake board member Pat Howerton replied that the plan is to complete construction on the school addition and then address the needs of the track, which he said will be a major project involving re-orienting the facility. He hopes to include a football field when that happens.

Abadie asked that Grand Lake School's track team be allowed to use South Cameron's track at no charge for the one track meet it hosts, until they get a good track of their own.

Hackberry board member Dwayne Sanner asked that when the Grand Lake track is considered, Hackberry's track be upgraded to a rubberized

surface.

## PIPELINE TAXES

Supt. Doug Chance and board accountant Margaret Jones reported that the judge in the pipeline tax protest case has made a decision, and "we have lost the battle, but may have won the war." The judge ruled in favor of El Paso pipeline company that they had been discriminated against by having the state assess their taxes.

However he directed that pipelines be assessed by local tax assessors instead. Since the revenue was previously spread around the state, and now will go only to the parishes in which the pipelines are located, "we should come out ahead," Chance said.

Another source of future revenue for all parish agencies will be the pipelines being built by LNG facilities in the parish. When the LNG terminals go on line, the parish will also be able to tax inventory (LNG) as it passes through the facilities. The structures themselves will be tax exempt for 10 years.

## RESIGNATIONS

South Cameron Elementary School Principal Barry Wayne Richard will be retiring on June 10 after serving 28 years as a principal. Also leaving at the end of the current term are South Cameron High School secretary Charlotte Broussard, teacher Elizabeth Richard, and teacher's aide Carolyn Primeaux.

Hackberry High School teacher Linda O. McKinney, Johnson Bayou High School teacher Staci P. Brown, and Cameron Elementary School cafeteria tech Janetta Theriot LaLande are also retiring.

The school board will be advertising for replacements, but may move some existing personnel into some of these positions and then hire some replacements for those persons. The School Board will approve all assignments.

**Justin Billiot completes Navy basic training**

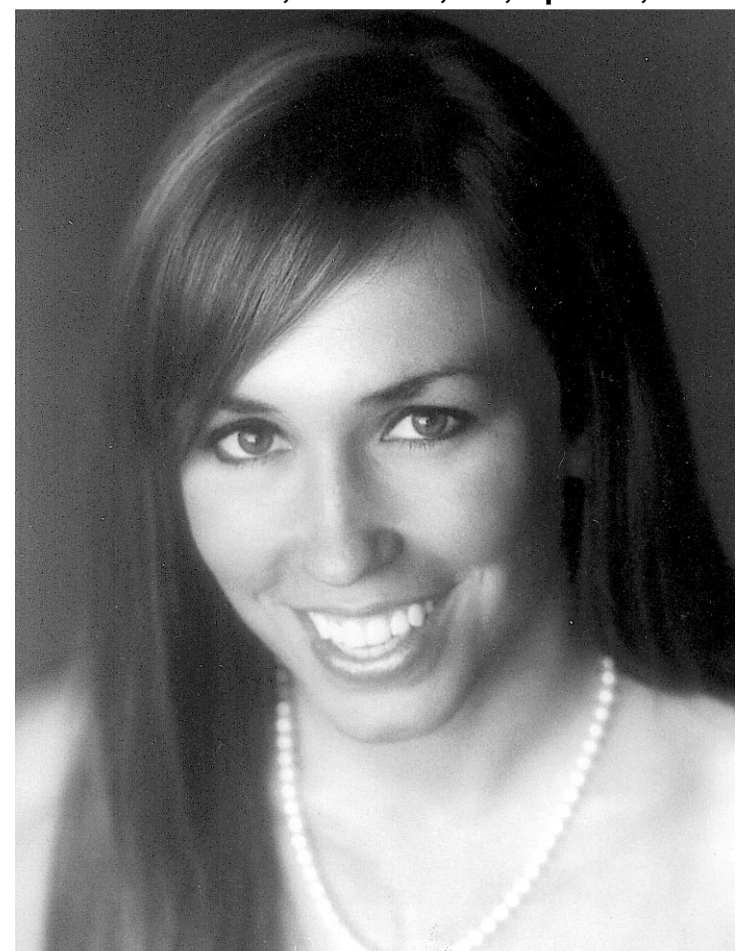

The price of duck hunting went up a few years ago, when lead shells were out and steel shot were in. That added over five dollars to a box of shells.

Now in case you haven't noticed, as the price of gas goes up, that six gallon outboard tanks is getting expensive. Last summer we paid about \$1.59 per gallon which made a tank cost \$9.54. Now the same tank at \$2.23 a gallon cost \$13.38, plus we still have to buy the two to three dollar a pint of oil to add to the gasoline.

Gas is taxed by both state and federal taxes, but do we know where the taxes on our boat fuel goes? We know its supposed to go for road taxes and yes we travel the highways and drag our boat with us, but tanking up on the water at the marina seems to be different.

I do know some states use this money for boat launches, game agents, some for the sport fish restoration account, and in some states, it's given back to the marinas themselves, kind of like years ago where you asked a friend where he was working. He'd reply he was in the "No Hog Raising Business," meaning the federal government would pay him not to raise hogs, as the market was flooded.

The Hog Bayou area in Grand Chenier had reports of a few red fish and also in the Rockefeller Refuge saltwater area.



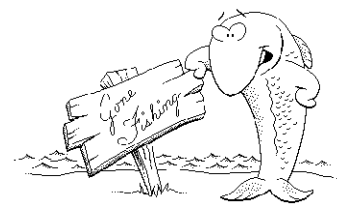

Bass fishing in the big burns is slow, but still a few fair bass reported. The area is growing up fast as water is lower than it has been. The Eastern Miami's Permit fishing is still doing well on bass and nice large catfish. Rockefeller Refuge's bass fishing is still good, but again strong winds have made it rough on bass anglers as well as saltwater anglers.

Lacassine Refuge is getting rougher to fish as the water is lower. Some trails are showing mud from the outboard motors and the ponds are getting real thick not only from growth, but lot more weeds sticking up with the lower water. The hotter it gets and the lower the water gets, oxygen levels will go own and big bass won't make it. Trying the marsh, some of the ponds are shallow enough to forget the trolling motor, but letting the wind do the work, can get you in trouble, as it's too hard to pole and rough on the outboard's water pump trying to get back to a trail that could be shallow.

Reports of bass being caught, but lots of work. As the water lowers to the level they want, bass will get caught in deeper water, and that's where anglers will have a "Hay Day", if they can get to the spot.

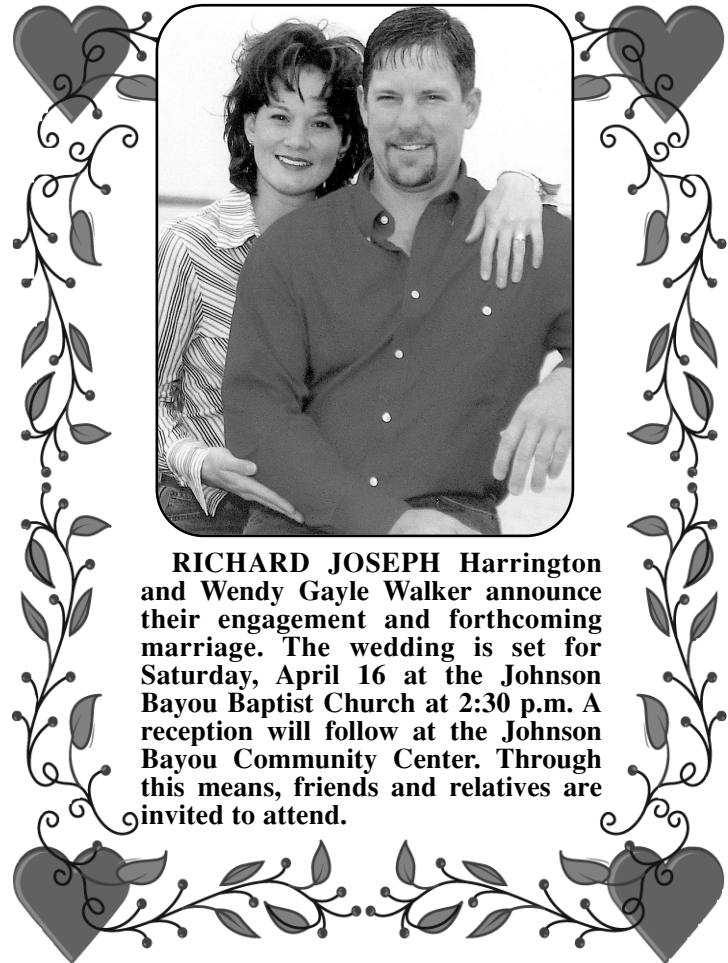

## Letter to the Editor

Dear Editor:  
A couple of months ago, articles began appearing in the Lake Charles American Press about changes in the way that Lacassine National Wildlife Refuge would be managed and maintained. These articles really lit a fire under a lot of area fishermen, myself included.

I wrote a letter to the editor and I immediately started an e-mail campaign contacting as many state and federal politicians as possible to express concerns and displeasure with what I was hearing and having friends doing the same.

Apparently, this started quite a stir between the public and the management of the refuge and for that I will not apologize. It was good to know that people, along with politicians will get involved with something that was this important to so many people.

Since the initial article, five or six more have been run

in the paper; each giving the same dismal news to the fishermen of this area. The fishery of Lacassine Refuge was in serious trouble. Although, some amazing catches have been coming out of there, the long term forecast looks bleak.

Recently, a friend and I sat down with Mr. Don Voros, Complex Manager of the Southwest Louisiana Refuge Complex which is responsible for the management of Lacassine Wildlife Refuge to clear the air on some of the issues that had everyone's ire up.

I have to admit that Mr. Voros was not the brick wall that I expected. He came to the meeting with all of his data to support his management practices and he was very open and receptive to hear everything we had to say.

It seems as though a lot of the disgruntlement may be a result of some inaccurate reporting by the American Press. Some of my questions were cleared up with simple explanations. Some of my concerns opened Mr. Voros' eyes to public perception. In short though, it seems as if things aren't as bad as they appear on the surface.

We spent about an hour and a half going back and forth about numerous issues concerning the refuge, but in the end, I think we both came away with new knowledge and a new found respect for each other. I am not in agreement with everything he is doing and he doesn't agree completely with me, but the water is definitely not as muddy.

So, in the meantime, I will continue to fish the way I always do, continue to practice my own way of conservation, and in the end we will all just have to wait and wonder.

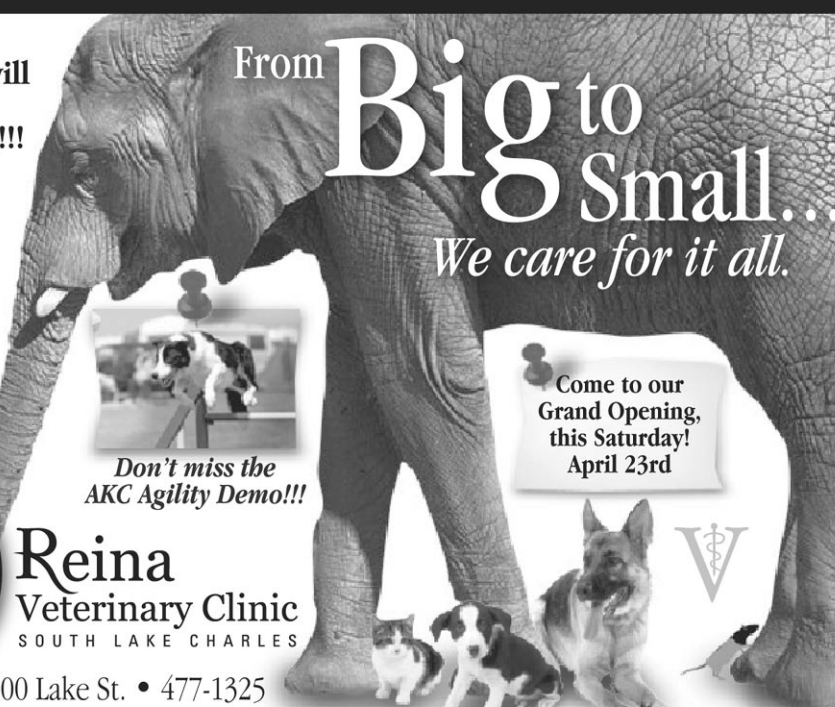

Mr. Granger, with Cheniere made a proposal for a waterline to the Chevron plant to the board members. Mr. Lonnie Harper discussed the approximate cost for an 8"-10" line of this distance. Mr. Sonny McGee, James Ducote, and Julie Benoit will begin application for a grant. The board will review findings at the next meeting.

Sealed bids on surplus metal were opened and reviewed. The following bids were submitted: Curtis Trahan - \$210.00, Travis Trahan - \$252.00, Charles Jinks - \$216.00, and Ray Young - \$206.00. With Travis Trahan being the highest bidder, it was moved by Mr. Simon, seconded by Mr. Badon and carried to accept said bid.

Due to low water pressure at a homeowner by the ferry, orifice plates for companies on the ferry line were discussed. The mtnc. specialist are to keep track of pressure and inform companies that larger storage tanks would be an

asset to their business. Updates on pressure will be discussed at the next meeting.

The possibility of a new well was discussed. Rhonda will get with Mr. Cecil Sanner about legalities and have him present findings at the next meeting.

There being no further business to discuss, president Nathan Griffith adjourned the meeting at 9:00 p.m.
