# Crain family honored by birder organization

The Louisiana Ornithological Society, at its Spring Meeting in Creole last Saturday, presented an award to a local family for their efforts to preserve and make accessible prime Cameron Parish birding habitat. Hilda Crain accepted the President's Award on behalf

of the Butch Crain family.


LOS spokesperson Marty
Guidry presented the award,
consisting of a plaque and a
first edition copy of Dr.
George H. Lowery's famous
book, "Louisiana Birds", in
honor of the family's efforts to
build a road to the Sabine
Pass Lighthouse, making the
excellent bird habitat accessible for study. Past Cameron
Parish recipients of the award
have been Marianna
Primeaux and Scott Henry.

Guidry explained to the 100 plus attendees that Cameron Parish is the largest land area parish in Louisiana, with a very small population. He called the parish "one of the best birding areas in the United States," with the annual Christmas Bird Count here usually ranking about 12th in the

nation, out of about 1700 counts. Only California and Texas have counts ranking higher.

During each LOS meeting weekend, birders try to see and identify as many species of birds as possible in one day. The Cameron Parish meetings in the spring usually have the highest count. This year, 206 species were identified during an excellent birding day. The weak cold front which passed through the area on Friday night contributed to the opportunity to see 30 species of warblers in the coastal woods, including a rare Brewster's Hybrid war-Other rare, for Louisiana, birds seen were the Yellow Headed Blackbird, Black-billed Cuckoo, Western Tanager, and Swainson's

The next LOS meeting in Cameron Parish will be the fall meeting held on the fourth weekend in October. Anyone interested in birds is welcome to attend the meetings, which always feature guest speakers. This spring's speakers presented slide shows on birding trips to New Zealand and Ecuador.

## Youths plan to attend Jesus rally


Several groups of students from Cameron Parish Schools will attend the Just for Jesus youth rally to be held Thursday, May 5 at the Lake Charles Civic Center.

## Pilot group supports Cheniere Energy plans

The Lake Charles Pilots announced their support Tuesday of Cheniere Energy's liquefied natural gas terminal planned for a tract along the Calcasieu River Ship Channel in Cameron Parish.

The pilots would navigate the huge LNG tankers up the ship channel and dock them at the proposed Creole Trail terminal, which if approved would be the third LNG terminal allowed to use the ship channel.

Pilots director Mike Miller said his group worked with Cheniere to design computer simulations of the flow of LNG tankers up and down the channel

The pilots rejected the first site Cheniere proposed for the terminal due to "severe traffic congestion," Miller said, adding that the pilots are satisfied with the current proposed location.

posed location.

"With the proper-size tractor tugs permanent to the project, the Lake Charles pilots feel that the Creole Trail project will be a safe and efficient facility," Miller said at a Tuesday public meeting hosted by federal energy regulators to gather comments on the project

The Federal Energy Regulatory Commission, the federal agency that approves all onshore LNG facilities, held the meeting as part of its process for preparing an environmental impact statement on the terminal.

The meeting is part of the prefiling process mandated by the National Environmental Policy Act.

Cheniere has yet to file its application for the Creole Trail terminal with FERC, but it's expected to do so within the next two weeks.

The environmental impact statement will then take 8-12 months to complete, FERC officials said.

Keith Meyer, the president of Cheniere's LNG unit, has said the company expects FERC to approve the Creole Trail project by early 2006 because the design is nearly identical to the Sabine Pass terminal already cleared by FERC and in the early stages of construction.

The Creole Trail terminal

will stand on about 300 acres of land along the Calcasieu River Ship Channel in Cameron Parish. Cheniere owns a total tract of 1,400 acres.

"These plants are very safe, but they're very large. And a lot of people don't like to live too close to a very large facility, so we looked for a very large site that provides a very large buffer zone." Meyer said.

It must first be approved by

It must first be approved by FERC. The entire permitting process is expected to take 12-18 months, with operations expected to begin in 2009.

The proposed Creole Trail Pipeline will be used to distribute the LNG to the nation once it is delivered by ship and reverted back to a gas. The pipeline will originate

at the terminal and extend about 118 miles northeast through Cameron, Calcasieu, Beauregard, Allen, Jeff Davis and Acadia parishes. It will end near Rayne.

Cheniere officials said they originally planned to run the pipeline west of the Calcasieu River Ship Channel, but the U. S. Fish and Wildlife Service nixed the route because it crossed over a small part of a wildlife refuge.

The company now plans to run the pipeline through the middle of Calcasieu Lake, though Cheniere officials said the route could still be changed.

About 15 miles of pipeline would be buried four feet under the lake bed, the company said. It would take about four months to complete the job, the company said.



Senate Bill 316 by Sen. Mount, Ď-Lake Willie Charles, was sent to the Senate floor Tuesday by the Senate Committee Revenue and Fiscal Affairs.

Mount is committee chairman and is sponsoring the legislation for Gov. Kathleen Blanco's administration.

Guglielmo, Elizabeth chairman of the tax commission, spoke on behalf of the legislation.

She said last year's law required parishes with a population of 75,000 or more to begin posting their assessments on the Internet.
