Congressmen visit

Cameron Parish received a visit from an influential Congressman on Tuesday, when Rep. Bill Shuster, senior member of the House Transportation

Rep. Shuster has now made four trips to the Gold Coast, but this was his first to Southwest Louisiana. Boustany showed his colleague the "critical energy infrastructure" in the parish, saying, "What we supply of oil and gas through this area is vital to the nation." Shuster said he hadn't realized how much there was in the western part of the state.

with local officials at the Court House to find out how the recovery is going. Boustany said "progress has been God-awful slow.'

Shuster has been pushing to remove FEMA from the Department of Homeland Security and return it to its former status as a separate cabinet level agency. He said the DHS is too big, with immigration, airport security, and other terrorism prevention functions, to adequately deal with disaster preparation and recovery.

"There is a cultural difference between the two functions," he said. "For example, every one of the 20 to 21 departments at DHS, except carries Prevention and preparation

'Get it to the road'

"Get it to the road." This is the message for Cameron Parish residents as June 12 will be the absolute final day to place hurricane debris beside the road for pickup by the Corps of Engineers.

At the first Police Jury meeting held in Cameron since Hurricane Rita, jurors were told that the final pass for right of way debris removal will begin rolling on that day. Until then, residents are urged to place all storm related debris beside the road and then call their juror or the Right of Entry office at 775-7048 and have the location of the pile listed. Crews will follow the lists to pick up the last of the debris. Any questions about debris removal should be directed to the Police Jurors, they said.

Hazardous household chemicals, paint, and ammunition should be reported to the EPA for pickup by calling the same number. The EPA

will not be making any more sweeps on private property. After the final pass ends,

around June 30, the parish will be responsible for the cost of disposing of any other materials left beside the road. Jurors pleaded with the public to get their debris out before the deadline, since the parish cannot afford a large clean-up bill. "We have citizens that will not clean their property," said OEP Director Clifton Hebert. Action by the Police Jury may be necessary for those properties.

All storm related debris is eligible for pickup. Not eligi ble are new construction debris and household garbage. For this reason, residents are asked not to bag their debris, but just pile it up. Concrete taken to the right of way will be picked up.

In the final pass, crews will pick up those piles of electronic equipment, white goods, small engines, and tires that have been left behind so far. These must be handled separately at the disposal site.

Jurors also learned that the Louisiana Department of Environmental Quality is finally about to begin removing derelict vehicles and boats from the highway rights of way. However, the contract does not include those dotting fields and pastures around the parish unless there is money left over. Residents who have hurricane damaged cars on their property may want to push them to the road to be sure they get picked up., said jurors.

Money to build a new hospital in lower Cameron Parish is now available thanks to a \$1.8 million state grant.

Engineering and design work for the hospital are under way, and its eight-bed emergency room is expected to open by September, Cameron hospital spokesman Jennifer Jones said Monday. The completed facility will have 25 beds, she said.

"Before the storm we had 49 beds," Jones said,"So our new hospital will be much smaller, but better for our needs.'

Some of the money will be used to help get the hospital going and to provide health clinics and pharmacy and

dental services, Jones said. Some will pay the 10 percent match required by the Emergency Federal Management Agency to build the facility.

"We have the money to build. Now we need money to operate the hospital," Jones said. "We are looking at a new hospital maintenance tax and other funding sources to help us get going. The state Department of

Health and Hospitals awarded \$21 million Monday to seven hurricane-ravaged areas to establish primary health-care services. The money is from a feder-

al block grant funding pool. Cameron Parish is the

only area in Southwest Louisiana to get funds. The other six are in and around New Orleans.

Her funeral was held Tuesday, May 30, in Hixson Funeral Home of Lake Charles. Burial was in Westlake Memorial Cemetery.



ROAD

The procedure will be for the State Police and Wildlife and Fisheries agents to tag each vehicle or vessel, noting its location by GPS. After three days, if the owner has not removed it, the vehicle or boat will be collected by a contractor and removed to a holding area. Owners will have 30 days to claim their property, after which it will be scrapped.

WATERWAYS

The Coast Guard reported that it has surveyed primary waterways navigable Cameron and Calcasieu parishes and identified 162 'targets", which could be sunken boats or other debris causing a hazard. Threefourths of the targets are in Cameron Parish. FEMA and the DEQ are reportedly working on options for removal of the 20 vessels that are outside the Coast Guard's assignment.

The Coast Guard has approximately removed 500,000 gallons of oil and oil waste from the vessels and 145,000 cubic yards of debris.

The several large vessels that are completely land bound along the Calcasieu Ship Channel are not within

the scope of any agency to remove, at this time. It is possible that the owners will salvage the vessels themselves.

Jurors took issue with the Coast Guard's definition of navigable waterways, which limits their activities to deep channels used for commercial purposes. All of Calcasieu Lake was excluded, even though it is extensively used by commercial fishermen who are getting their nets and gear snagged on numerous storm related obstructions.

Juror Sonny McGee asked how small 3'-4' deep bayous could be declared navigable by the Coast Guard to prevent gates being placed on them, but an 8' deep lake is not considered navigable. The matter will be referred to the Coast Guard legal department.

Parish Administrator Tina Horn asked that the Coast Guard continue their survey up the Mermentau River to Catfish Locks, since there is tugboat and fishing vessel traffic all through that waterway. Waterways already surveyed are the Calcasieu Ship Channel from the mouth of the jetties to the Interstate 10 bridge, the Cameron Loop, the East Fork, and the lower part of the Mermentau. Secondary

waterways were surveyed from the air.

The Coast Guard is compiling a list of new underwater obstructions. Anyone who has GPS data can send it to their Police Juror or the OEP and it will be forwarded.

DEBRIS COLLECTION SITES

The McCain dump site in Grand Lake has been a major source of concern for jurors for months, being the only dump located within a residential area. Residents have complained of the sights and smells of the debris, and are now reporting possible health problems from airborne contaminants.

The DEQ will take air samples this week to determine if there is anything dangerous coming out of the site. Air toxin analysis results will be available in about two weeks, spokesman Meanwhile, all 137 debris sites in the state are being physically inspected every 10

The Corps of Engineers reported that a financial agreement has finally been reached between their contractor, Phillips and Jordan, and the owners of the site for debris burial, and the size of the pile should begin to decrease in about two weeks.

Juror Darryl Farque said "I've been hearing "two weeks" for 55 days now. I'm at the end of my "two weeks. Homeowners don't want to hear another "two weeks" out your mouths." Representatives of the Corps said they have stressed in the strongest possible terms the need for the work to begin, preferably before the two weeks.





Hebert reported that there are still 36 residential demolition packages under review, and less than 22 public condemnations. It will not be possible to get all this demolition done before the June 30 deadline, especially since the hospital and school have


asbestos issues. This is a great concern to the Police Jury. "We were originally told that if it was tasked before June 30 it would be paid at 100%. Now it is not so. FEMA finds it easy to change their mind, but it is not so easy for the parish to deal with," said Farque. Horn said, "We need to pray for an extension.

Calcasieu Police Juror Brent Clement warned that there is no guarantee the cost split after June 30 will be 90/10. He said he has heard it could be 50/50 or even zero.



As you know, the South Cameron Memorial Hospital in Creole was destroyed by Hurricane Rita. Prior to September 24, 2005, the Hospital was the provider for the following services to the people of Lower Cameron:

- 1. A swing bed facility for our elderly, which was filled to capacity. This was of critical importance since Cameron Parish is the only parish in the State of Louisiana with NO NURSING HOME.
 - 2. Acute care services.
- 3. A rural health clinic in the town of Cameron.
- 4. AN EMERGENCY ROOM, WHICH SAVED LIVES. In the southeast part of Cameron Parish, you are ONE HOUR from the next nearest emergency room in Lake Charles.

All of this was lost in Hurricane Rita. Following the storm, we reopened our Rural Health Clinic in Grand Lake, where it is now operating successfully. Our swing bed patients were scattered far and wide. On September 24, we had 15 swing bed patients - TEN ARE NOW DEAD because they did not receive the quality of care we were able to provide at South Cameron. This is what happens when you try to get services provided by someone who has no stake in the community. This is what happened when St. Patrick's operated a clinic in Grand Lake.

We were told by the most vocal representatives of the area that the people in Johnson Bayou and Holly Beach were vehemently opposed to expansion of the district and a maintenance tax. despite the fact that this tax would be HOMESTEAD EXEMPT and almost no residents of Johnson Bayou would be paying any tax at all. We were given the following reasons why Johnson Bayou and Holly Beach should not be included in the hospital service district.

- 1. Johnson Bayou did not have a football team and South Cameron did
- 2. More importantly, South Cameron's wrestling uniforms were better than Johnson Bayou's (??).
- 3. Any tax money collected from Cheniere or any other industry located in Johnson Bayou or Holly Beach has to stay in Johnson Bayou or Holly Beach, because it is "theirs." Although we have parish-wide taxes for schools, law enforcement, even the library, YOUR **HEALTH AND SAFETY is not important** enough to justify a parish-wide tax, 92% of which would be funded by industry.
- 4. Johnson Bayou and Holly Beach do not need an emergency room and do not want to help support an boundaries of the Lower Hospital MONDAY, JUNE 5, 2006, AT THE emergency room in Creole.
- 5. This would be "taxation without representation." As we gave our presentation, there was even a chant to this trict's electorate. effect going on in the back of the room. The truth is that Johnson Bayou and Holly Beach have more representation on the Police Jury than any other community, since they have fewer voters than any other district, but still get their own police juror.

WHEN WE TOLD THE PEOPLE IN THE ROOM THAT UNLESS WE HAD ADDITIONAL MAINTENANCE TAX MONEY, THE HOSPITAL WOULD NOT REOPEN IN CREOLE AND PEOPLE IN THE SOUTHEAST PART OF THE PARISH WOULD DIE AS A RESULT, WE WERE GREETED WITH SPONTANEOUS APPLAUSE.

However, we were assured that it was " nothing personal."

OUR ONLY ALTERNATIVE IS TO DO THIS OURSELVES. WE ARE OUT OF TIME.

We have been going to the Police Jury since January trying to get some help. We have been "tabled" and referred to committees time after time.

The Lower Cameron Hospital Service District would like to publicly express our gratitude to Mr. Charles Precht, who attended the meeting in Johnson Bayou and was not afraid to express his support for the hospital. Mr. Jay Delafield, bond attorney from Lake Charles, has also been invaluable to us.

Unless we have parish-wide taxes, communities such as Grand Lake and Creole will be unable to provide essential services such as water and drainage.

HOWEVER, WE CAN WAIT NO LONGER FOR OUR NEIGHBORS TO BE WILLING TO SHARE. WE WILL IF YOUR CHILDREN ARE HURT NOT GET ANY MONEY FROM THE STATE OR FEDERAL GOVERN-MENTS UNLESS WE PROVE THAT THE PARISH CAN OPERATE THE HOSPITAL ON ITS OWN. THE MONEY FROM FEMA AND THE LRA WILL GO SOMEWHERE ELSE.

You can't argue with their logic. Why should they build a hospital nobody wants which cannot operate once it is constructed?

If you have arthritis, limited strength or have trouble bending or stooping over, here are some products that can help take the strain out of

gardening. •Ergonomic tools: There's a variety of ergonomic grip gardening tools, gloves, kneeling pads, garden stools, carts and other equipment that can help make your gardening chores a lot easier. Two good resources that offer many of these unique tools and equipment are www.gardeningwithease.com or 800-966-5119, and www.handhelpers.com or 888-632-7091.

•Long-handled tools: You can reduce the bending and stooping that typically goes along with gardening by using long-handed or telescopic tools. See www.hounddog.com or call 800-694-6863 for a nice variety of sturdy "back saving" tools for both lawn and garden care.

Battle of Calcasieu Pass only Civil War recalled

(EDITOR'S NOTE--The following article was published in the Pilot some years ago. It was written by Geneva Griffith, who reported for the paper for over 40 years. Mrs. Griffith now lives in a retirement village in Baton Rouge.)

The Battle of Calcasieu Pass on May 6, 1864, which took place at the mouth of the Calcasieu River, off Monkey Island, was the only battle tookplace in Southwest Louisiana during the Civil War.

Cameron Parish as a political entity, was not organized until after the war ended. Because of its isolation from the outside world, it became, in a sense, a "No-Man's-Land", neglected by the Confederacy because of its inaccessibility, and prized by the Union navy as a source of

Due to the lack of law and order in the area, Cameron Parish became a haven for deserters, draft dodgers, Union Sympathizers and criminals.

Especially troublesome were the Jayhawks, a band of desperadoes who roamed the countryside stealing, looting, burning, and killing.

Oddly enough, it was the Jayhawkers who were instrumental in bringing about the battle of Calcasieu Pass.

The battle brought together two determined foes -Union gunboats bent on "purchasing" stolen livestock and recruiting men to serve in the navy, and a "scrappy" band of Confederates determined to expel the invaders.

The two Union gunboats, Granite City and Wave, received orders April 15, 1864, to proceed to Calcasieu Pass to buy 250 head of cattle and 200 horses from the

Jayhawkers who have stolen the livestock from area farms.

The Wave arrived April 24 with gold for the purchase, bombing an abandoned Confederate fort on the way and anchoring two miles upstream.

Lt. Benjamin W. Loring was the commander and its armament included four 24pounders, a 32-pound rifle, and a 20-pound Parrott rifle.

The Granite City, commanded by Lt. Charles W. Lamson, arrived two days later and anchored about 300 yards from the Wave, around the bend in the river.

The arrival of the gunboats abruptly reversed Confederate neglect of Southwest Louisiana, and when Col. W. H. Griffin, at Fort Manhassett in Sabine Pass, received word of the landings, his first thought was: "This is it - The Invasion." He immediately wired General J. B. McGruder's Houston headquarters for instructions.

His reply was, "Attack the small force at Calcasieu at once, and disperse, defeat, or capture the expedition."

Major Felix McReynolds, Commandant Fort Manhassett, led its two companies - one from Griffen's Battalion and one from Creuzbaurer's Battery - along with other units, numbering about 300 in all, for the Fort to Calcasieu Pass, (during the night to avoid detection) and began the attack on the two gunboats at daylight.

Creuzbauer's gunners opened fire at 1,000 yards to Creuzbauer's cover the infantry's advance to the banks of the Calcasieu the brave confederates making their stand in the salt grass march without any benefit of cover.

The confederate infantryman had the benefit of surprise, but could get off only 10 rounds before the two gunboats opened fire.

In only 2 1/2 hours, the two gunboats had been knocked out by the crossfire of the confederate muskets 22Union Confederate soldiers had gallantly died for their cause, many remaining behind to be buried in simple graves marked with white picket crosses on Monkey Island.



During the days immediately before and after hurricane Rita, many such "exempt" employees worked extremely long hours for which they were not compensated. The Jury will consider the matter at its regular meeting on Monday.

Staff reported that work is about to begin on the Oak Grove Bridge repair. Parish employees will first remove the water line that crosses the canal. Then the contractor will be able to begin. When the repairs are done, the Creole bridge on Hwy 27 will be closed and traffic re-routed through Oak Grove until that bridge is replaced and widened.

Plans are being made to replace street lights along the main street in Cameron, and perhaps in neighborhoods where people have returned to live.

Parish Administrator Tina Horn is to meet with Waste Management this week to discuss re-instating garbage pickup in lower Cameron Parish, and plans are underway to begin to clean out the drainage ditches in the area, as well.

with staff staying for three years, and things ran much more smoothly. We should have the same thing here."

Shuster said the bureaucratic red tape involved with moving the funds from Congress to the areas that need them is frustrating. He said there is money to fix the levees for marsh restoration. "\$3-\$4 million is peanuts compared to how much damage it will stop," he said. "The federal government needs to operate more streamlined, in some ways like a business.'

Both Congressmen were outraged over the handling of the debris in Sabine National Wildlife Refuge. The Stafford Act would not allow federal disaster funds to be used by FEMA on federal lands. Now, apparently, money has been found elsewhere. Donald Voros, refuge employee, said "Now we will have to re-mobilize and spend a lot more taxpayer dollars to clean up this toxic waste dump on Sabine

Boustany said "The stupidity of it was that it could have been taken care of earlier." The massive piles of debris have begun to sink into the marsh, including whole eighteen-wheelers.

Other concerns shared by local officials included housing, seafood industry support including an ice house, better evacuation routes for SWLA, cleanup of drainage and navigable lateral waterways,

dredging of storm surge silt from the Cameron loop, preliminary elevation maps that "make no sense," unreasonable elevation requirements, a hospital, and ferries.

The looming June 30 FEMA deadline for 100% reimbursement is one of the greatest worries for the parish government. Administrator Tina Horn said the parish can't afford to pay even 10% of the cost of removing vehicles, demolishing public buildings, and landfilling debris. The entire parish budget is only around \$3 million per year, therefore an extension of the deadline is desperately needed, she said.

Juror Charles Precht said "The thing that cripples Cameron Parish is population You're at the bottom of the bucket if your population is under 10,000." He pointed out that the 6000 people in Cameron Parish support oil and gas, Creole Nature Trail tourism, and thousands of workers flying out to the Gulf of Mexico oil platforms. And when Katrina threatened New Orleans, Cameron had four times the number of oil field vessels shipping out of its nort, because companies were looking for alternate ports.

Shuster said he is from a rural area of Pennsylvania, and it is his goal to make sure the needed money gets to the smaller towns and rural areas that need it, not just the big cities like New Orleans.'

Bureaucracy defends the status quo long past the time when the quo has lost its status.
