Restrictions expanded on vehicles on the beaches

Restrictions on vehicular traffic on West Cameron beaches were expanded by the Police Jury Monday evening. At their regular voting meeting, jurors considered the request of Beachfront Development District #1 and objections by Creole resident Jay Rutherford.

The new amendments to the parish's existing beach speed limit and prohibition law set a speed limit of 10 mph on all beach areas between the Calcasieu Ship Channel and the Louisiana -Texas line.

Previously, only certain areas had speed limits. Juror Sonny McGee said law enforcement officials had asked for consistent speed limits along the beaches to aid in enforcement.

Vehicle prohibitions have been expanded for two areas. In Holly Beach, off-road vehicles (such as four-wheelers) are now prohibited from Beach Post #1 on the east to Beach Post #30 on the west, or one-half mile east of Barataria Blvd. to one-half mile west of Riviera Lane.

Most of this area has been off-limits to four-wheelers for years, but the parish ordinance written last year did not clearly say so. The clarification and expansion are an attempt to prevent injuries in a highly utilized area, according to McGee.

Cars and trucks are only permitted to park on the beach, not to drive along it, in this area.

All vehicles are now prohibited on the "new beach" from Prioux Lane (PR 519) east to the beginning of the erosion fencing. McGee said the state required this prohibition, having spent some \$14 million to pump sand in to create the beach there.

Rutherford read a letter to the jury expressing his opposition to prohibitions on fourwheelers on any beach, saying this will lead to a eventual prohibition on all parish beaches. He asked that, instead, responsible drivers be allowed to take a class and get a permit to allow them to ride on the beach, and penalties for bad drivers be increased. He also opposed the expansion of the 10 mph speed limit to all west Cameron beaches, saying it should stay only in the populated areas.

McGee cited two recent four-wheeler accidents resulting in serious injury to chil

Former local boy among top spellers

(Lake Charles American Press) Local spelling champ Alex Ducote of DeQuincy gained national attention for Southwest Louisiana Thursday when he finished in the Top 10 at the Scripps National Spelling Bee in Washington, D.C. last Thursday. Alex lives with his grand-

Alex lives with his grandparents, Wesley (Tom) and Silva Marcantel in DeQuincy. His mother is Laura Strother and his father, Mark Ducote, is deceased. Alex formerly lived in Creole with his parents and attended South Cameron Elementary School. He now attends DeQuincy Middle School and is attending the Governor's School for Gifted and Talented Students at McNeese this summer.

"I wish I would have been in the Top 3, but I'm not complaining," he said not long after the competition ended.

Ducote made it through four of the 14 championship rounds, which aired live on ESPN, by correctly spelling the words "arenicolous," "pergelisol," "rucervine" and "achroacyte."

The word "Pepysian" did him in. He spelled it "Piepsian."

He said it threw him because the word comes from the proper name of Samuel Pepys, a Londoner who kept a detailed diary of his life from 1660-69. His name is pronounced "Peeps," which further threw Ducote off.

Ducote's grandmother Silva Marcantel said the day had been a stressful one.

In fact, Ducote said he pretty much knew how to spell all the words that came up after he lost, including the winning word, "appoggiatura," which was spelled by Anurag Kashyap, 13, of San Diego, Calif.

Overall, Marcantel said Ducote was taking his loss well.

Ducote did come away from the bee with a special souvenir--the "s" from the Scripps National Spelling Bee sign from the set.

It fell off at some time during the competition and officials said he could keep it.

Ducote also offered to tutor next year's regional spelling bee winner.

04 Port to repay Police Jury loan

The West Cameron Port Commission last week formalized its position on repaying the Cameron Parish Police jury for the expenses of hiring an attorney to handle its legal negotiations with the Port of Lake Charles.

On May 31, the board adopted a resolution affirming its intention of "paying all monies back to the Cameron Parish Police Jury with monies received from lease agreements with Cheniere Energy, LLC and Gulf Coast Development, LLC and issuing permits."

Questions had been raised by Grand Chenier resident Teddy Broussard as to how much the attorney would cost, and whether the parish would get the money back. Attorney fees to date are around \$68,000 according to the Police Jury. The funds in question are not a loan, according to WCPC members, but an appropriation by the jury for a public purpose. However, the board has always expressed an intent to pay back the money when revenues are available.

Leases signed with Cheniere Energy, LLC provide for the payment of \$1000 to the port board for each LNG carrier berthed at the Sabine Pass and Chenier Trail LNG Terminals. Between 300 and 400 ships per year are expected to berth at each facility when they begin operation.

The Sabine Pass facility is in the first phases of construction at this time, and expects to be on line in three years. The Creele Trail terminal

The Creole Trail terminal has yet to receive a Federal Energy Regulatory Commission permit, but the prospects

look good for early approval.

One issue which could cause trouble for the Creole Trail facility is a letter recently sent to the FERC by the TCEQ, which is the Texas division of the Environmental Protection Agency, equivalent to the LDEQ in Louisiana.

Howard Romero reported to the board that the TCEQ is asking for more stringent operating rules for Creole Trail, saying the emissions from the terminal could adversely affect Port Arthur's air quality, 40 miles away.

Romero questioned why the TCEQ didn't object to Cheniere Energy's two LNG facilities already permitted in Texas, or the Sabine Pass facility located across the river from Port Arthur. Also, there are two LNG terminals currently proposed for Port Arthur itself.

Romero questioned the involvement of the Texas agency in Louisiana permit process, saying the LDEQ has never gotten involved in Texas permits. Police Juror Charles Precht noted that the TCEQ did not attend any of the FERC hearings on Creole Trail, however there is a mail in comment period. The board voted to write a letter to the FERC protesting the TCEQ's involvement, and asked the Jury to do the same.

Audrey Museum to tell story of storm

The Creole Nature Trail All-American Road and the Southwest Louisiana Convention and Visitors Bureau have received grant funding from the Federal Highway Administration through the Louisiana Department of Transportation to develop a state-of-the-art Hurricane Audrey Museum/Interpretive Center.

"This planned project will be an important part of enhancing the visitors' experience along the Creole Nature Trail All-American Road, and therefore improving the economy of our area," said Monte Hurley, Chairman of the Creole Nature Trail Board of Commissioners. "Also, this proposed facility will act as a memorial to the more than 500fellow Southwest Louisiana residents who lost their lives during the horrific disaster beginning June 27, 1957.In addition, the plan calls for the facility to be an educational tool for teachers and parents to explore science. technology and technological advancements in satellites, research aircraft, radar systems, building codes, evacua-tion standards and other weather related systems with their students and children. A hands-on approach to the science and technology portion of the facility will be the goal. Grant funding already in place for the project requires that the Center must also focus on the effects of weather, climate and hurricanes on the natural resources, history, culture and other intrinsic qualities of the byway and its people. The project is seeking to gain community input and grassroots support. Cameron State Bank, KPLC and other media partners have stepped forward to assist in the solicitation of this support. "This project can grow to be as broad and impressive as our communities envision and are willing to support," said Leslie Harless, Marketing Director for Cameron State Bank. "We wanted to be a part of making this center a reality from the very beginning."

Indigo plants found growing wild here

According to Louisiana Environmentalist of May-June 1995, Dr. Gary N. Ross, professor emeritus at Southern University, visited Cameron Parish in 1991 during a research sabbatical. He pointed out to the local citizens of Creole and Oak Grove the strange plants that grew there in the barbed wire fences, and his exact words were, as follows:

"... The plants are particularly abundant along the pasture fences bordering the north side of Highway 82 between Cameron and Grand Chenier. The plants are easy to recognize - perennial shrubs sprouting in late spring from perennial root stocks - multiple stalks up to six feet high, with green, feathery leaves . . . delicate pea-shaped, pinkish colored flowers, followed by green or black seed pods, that cluster in banana-fashion in October or November . . ."

Cameron Parish residents knew the plant only by its localized name or else, by no name at all. When they were questioned about the bush's origin in the parish, Dr. Ross was disappointed to learn that they knew nothing about either the plant's origins or its properties. The shrub is known to botanists as *"indigofera suffruticosa,"* which is the Latin-American variety of indigo.

The Middle Eastern variety of indigo was in use by 1,000 B.C. Egyptian mummies were occasionally wrapped in blue-indigo dyed






Danceline applications being taken



The Johnson Bayou Volunteer Fire Department was recently the recipient of one of the first pediatric capable Automated External Defibrillators in the area.

The distribution of the AEDs are made possible through a grant from the Department of Health and Hospitals, Office of Public Health and The Bureau of Emergency Medical Services. The goal is to place 110 AEDs in rural communities across the state this year.

The AEDs are part of a new early defibrillation program that trains individuals to recognize a cardiac emergency and use the device to shock the heart into a regular rhythm. Every year almost 250,000 people suffer cardiac arrest and only about five percent of them survive.

Cardiac arrest is a condi-

linens, and their eyes were often painted with an indigo cosmetic eye shadow. Rugs found in early Persia or Babylon were also dyed the color of indigo blue.

When the British first founded sugar plantations in the West Indies about 1650, they were quick to add the production of indigo plants for the English woolen market. The proprietors of Colonial South Carolina quickly imported indigo seeds, and by 1700, rice, indigo, and naval stores were South Carolina's principal exports to England. New Orleans was founded by Jean Baptiste LeMoyne in 1712, and due to its early trade wih Haiti, indigo was quickly introduced to the early sugar planters to the extent that New Orleans exports of indigo were worth \$1.3 million in 1763. However, by 1800 its export value had been cut in half, and after German chemists discovered a synthetic blue dye about 1850, the extensive use of indigo as a source of blue dye quickly subsided. However, that leaves unanswered the question of indigo arrived in Cameron Parish? According to Dr. Carter Sweeney, an early physician of Grand Chenier (and the writer's great uncle,) Capt. Paul Jones became the first merchant at Grand Chenier about 1845; and every three months, Capt. Jones sailed his schooner Jubilee, loaded with cotton, as well as cattle, deer, and mink hides, to New Orleans, and he would return with all the merchandise needed to sustain Grand Chenier's frontier economy. Most probably realizing that the local house wives wished to dye their homespun clothing with a bright color, it seems only logical that Capt. Jones also imported the indigo seed, thus creating another frontier chore that survived until synthetic dyes became available. Whatever the origin of Cameron Parish's indigo plants, they hint of another era of frontier living - when the frontier wife and mother spun her thread on a spinning wheel, then produced a rough, homespun cloth on her primitive loom, and then dipped it into a boiling vat of blue indigo dye. As a result, her best dress would appear a bright blue hue for the next Sunday's church service, and children's homespun clothing would no longer evince the dull shades of undyed wool or cotton.

My daughter gave me a unique birthday gift this week, a lunch out with three of my best friends. It was hard to decide on three because I love everyone I meet. Should I invite my crawfish gang, my Bible study gang, or my casual friends. I ended up inviting my next door neighbors and my friend that picks me up every Sunday morning for church. ing service. We are looking forward to our social next month down by the clubhouse. We are to celebrate the 4th of July with a pool party down by the swimming pool. I am wondering how many people here will be brave enough to go in swimming in front of that crowd. Ha, ha. I am looking forward to

I am looking forward to enjoying the hot dogs and hamburgers.

The daily showers have interrupted our daily walks. Beau and I have to be happy with just staying inside, because there is no way we can anticipate when a shower will pop up and catch us on our walks.

My tomato vines, which I have planted in the flower beds in my front yard, are loaded with fruit. I am anxious whose plants will ripen first, mine or my neighbors. It's wonderful to form such closeness to people like this. We just feel so safe in our own little world here.



dren, one a three-year-old who had to be air-lifted to the hospital, as the reason for reducing the speed limit and restricting use.

He said no one under 16 should drive four-wheelers, but people let young children drive without supervision. He said it would be impossible to enforce a permit system, and a person who might pass a class could still behave irresponsibly on the beach, especially when alcohol is involved.

A reduced speed limit for Benoit Rd.(PR 301) in Sweet Lake was tabled until next month.

OTHER BUSINESS

Jurors voted to hire three summer workers, two from Johnson Bayou and one from Hackberry, to clean the beaches during the season. McGee reported that the seaweed has arrived and the tractor will be needed immediately to clear the public beaches on the west side. The parish garbage fund will cover the cost.

Jurors also agreed to purchase rabies vaccine at a cost of \$1.50 per dose, up to 500 doses, for use in Rabies Clinics to be set up soon. The price to the public will be set as soon as the District Attorney's office determines what is legal to charge.

The fee will have to include the cost of tags, syringes, and office expenses. The veterinarians have volunteered their time, according to Ryan King of the health department.

Several bids were accepted. Ferrara Fire Apparatus, Inc. was low bidder on a rescue truck for the Johnson Bayou Fire Department, at \$173,186; Coastal Culverts submitted the only bids, at various prices, for culverts; and the Cameron Pilot was named as the parish's official journal for the next year, with a bid of \$6 per square.



The immedi-ate effects of LPSC Order No. U-20925 (RRF 2004) are to (1) eliminate the \$18.3 million rate increase that was implemented on an interim basis pursuant to Article IV, Section 21(D)(3) of the Louisiana Constitution and Title 45. Section 1163.1 of the Louisiana Revised Statutes effective the first billing cycle of May 2004 (April 29, 2005), and (2) to provide for a refund (with legal interest), which will return to customers the increase collected pursuant to said interim rates. Additionally, rates have been adjusted to reflect implementation of the change in facilities charge rates approved in LPSC Order No. U-27167. Rates charged pursuant to LPSC Order No. U-20925 (RRF 2004) may be subject to future adjustment upon further analysis of certain issues resolved in the settlement approved by the Commission in its Order.

The June decrease is anticipated to have the following effects upon ELI's customers' bills based upon April 2005 Fuel Adjustment Charges. A bill for Residential Service for 1,000 kWh will decrease \$0.75 from \$86.64 to \$85.89, a decrease of 0.9%. A bill for Commercial Service for 40 kW and 10,000 kWh would decrease \$10.33 from \$965.18 to \$954.85, a decrease of 1.1%. A bill for Industrial Service for 1,000 kW and 400,000 kWh would decrease \$255.05 from \$29654.64 to \$29399.59, a decrease of 0.9%. The increase that was in effect for the month of May will be credited to customers' August bills with legal interest.
