Board President Thomas McDaniel called the meeting to order at 5:30 p.m. at the Cameron Main Library. Board Members present were Lisa Hunt, Helen Williams, Thomas McDaniel, Jaimie Boudreaux, Beth Ferguson and Kathy Helmer. Board member not present were Kirk Quinn. Guests were Teressa Porche, Becky Primeaux, and Tina Boudreaux.

The prayer was led by Helen Williams and Jaimie Boudreaux led the Pledge of Allegiance.

On the motion by Lisa Hunt and seconded by Jaimie Boudreaux, and carried, the reading of the minutes of the August 18th meeting were approved.

On a motion by Beth Ferguson and seconded by Helen Williams, and carried, the board voted to accept the financial and expenditure reports.

Sherry Seat and Clair Marceaux gave information on how the libraries could help market our parish to new visitors and residents.

On a motion by Lisa Hunt and seconded by Kathy Helmer, and carried, the board voted to piggy back off the Livingston Parish Library Materials contracts
